## BY-LAW 15-0001

**Being a by-law of the Rural Municipality of Gimli to Amend By-Law 14-0009 being a By-law of the Rural Municipality of Gimli to establish Reduced-Speed School Zones**

**WHEREAS** *The Municipal Act* of Manitoba, C.C.S.M, c. M225 provides as follows:

“147(1) The power to pass a by-law under this or any other Act includes the power to amend or repeal the by-law.

147(2) The amendment or repeal of a by-law is subject to the same requirements that apply to passing the by-law, unless this or any other Act expressly provides otherwise.

**AND WHEREAS** the Council of the Rural Municipality of Gimli deems that it is in the best interest of the Municipality to amend By-Law 14-0009;

**NOW THEREFORE** the Council of the Rural Municipality of Gimli, in a meeting duly assembled, enacts as follows:


That By-Law 14-0009 of the Rural Municipality of Gimli is hereby amended as follows:

Section 5 is deleted in its entirety and replaced with the following:

The reduced maximum permitted speeds established under section 4 apply within a reduced-speed school zone from 7:00 a.m. to 6:00 p.m., Monday to Friday from September 1 to June 30
